**Subject: Chartco Ltd publication Licence - "Regs4Ships" product**

I wish to refer to your application for renewal of your licence to publish the Merchant Shipping Legislation of the Republic of Cyprus, Circulars and Sanctions Information Notices (SINs) of the Shipping Deputy Ministry to the President, which are accessible on the Shipping Deputy Ministry's website.

2. The Shipping Deputy Ministry hereby renews the Licence granted to Chartco Ltd ("Regs4Ships" product) to publish, in a subscription website, digital download and DVD product, the following (hereinafter cited together as "the Shipping Deputy Ministry's material"):

- (a) The consolidated and translated into English Merchant Shipping Legislation of the Republic of Cyprus which is available on the Shipping Deputy Ministry's website;
- (b) The Circulars of the Shipping Deputy Ministry that are available on the Shipping Deputy Ministry's website; and
- (c) The Sanctions Information Notices (SINs) of the Shipping Deputy Ministry that are available on the Shipping Deputy Ministry's website.

3. The above Licence is renewed subject to the following **terms and conditions**:

- (a) The Licence is not exclusive, therefore the Shipping Deputy Ministry reserves the right to publish the material itself and to licence others to do so;
- (b) The material shall be published as it appears on the Shipping Deputy Ministry's website and its format, content and appearance shall not be modified for any reason whatsoever without the prior written consent of the Shipping Deputy Ministry;
- (c) Chartco Ltd shall incorporate in its subscription website all updates, additions and amendments to the Shipping Deputy Ministry's material within 3 (three) weeks from the posting of such update, addition or amendment on the Shipping Deputy Ministry's website or receipt of notification to this respect by the Shipping Deputy Ministry;
- (d) When reissuing the digital download or DVD product, Chartco Ltd shall include therein the material with all its updates, additions and amendments and shall stipulate the following wording with respect to the DVD product:

*"The reproduction (or production in case of the first DVD product) of this DVD is licensed by the Shipping Deputy Ministry to the President of the Republic of Cyprus"*




- (e) The assignment of the Licence is not permitted;
- (f) Chartco Ltd shall provide, free of charge, five (5) usernames and passwords for full access to its entire website;
- (g) Chartco Ltd shall provide the Shipping Deputy Ministry, free of charge, two (2) copies of its DVD Product and of all updates.

4. This Licence is valid for four (4) years and is subject to renewal at the request of Chartco Ltd. The Licence shall be automatically terminated upon breach of any of its terms or conditions.

5. The Shipping Deputy Ministry may, at any time, withdraw the Licence provided it gives Chartco Ltd a notice of six (6) months.

6. The Shipping Deputy Ministry may amend any of the terms and conditions of this Licence if deemed necessary and shall notify Chartco Ltd in this respect. This Licence replaces our Licence dated 02/04/2015.
